Capital Developments Update

Funding for the first four (4) home developments occurred in 2021-2022. Additional approvals are anticipated in 2022-2023 and 2023-2024 to fulfill the Manor Transition Initiative.

- Minimum of **50 Foot Lots** located within Saskatoon
- >1,800-2,000 sq/ft fully accessible bungalows
- ▶ 4 Bedrooms per Community Home
 - **▶2** Bathrooms per Community Home





Key Elements of Community Homes

- Minimum of 50 Foot Lot
- 2000 Square Foot Bungalow
- 4 Bedrooms per Community Home all ceiling tracked to support aging in place
- 2 Bathrooms per Community Home
- 1 Bathroom with OT recommended tub to meet needs of residents and 1 Bathroom with fully accessible shower
- Each resident will enjoy their own private bedroom in their new home
- Unique features based on resident requests and preferences will be considered in the builds of the homes. For example: consideration of fire pit, garden space for residents to enjoy

Resident Engagement Plan



In line with our Resident First Approach, Elmwood believes that our residents have the right to be informed, engaged and participate in their journey of transition.

- Information will be shared by taking a Person-Centered Approach.
 - 1:1 Discussions
 - Roommate Groupings Discussion
 - Ground Breaking and Construction Tours



- Importance of residents to be informed, engaged and participate in their journey of transition.
- Manor Transition Project Specialist to have 1:1 conversations with residents of first 4 homes and provide an update to each individual in the coming weeks.
- Conversations with resident groupings as part of the first 4 homes to occur within the same day.
- Information will be shared by taking a Person- Centered Approach to ensure those individuals which desire information, receive it.
- To support residents who will struggle with too much information, basic updates will be communicated by taking a Person- Centered Approach.
- Provide residents the opportunity to gather on a regular basis to ask questions, play an integral role in their transition and provide feedback
- Importance of residents to maintain existing socialization opportunities, and expand scope and frequency of activities and events

Family Engagement Updates

- All families of residents of houses #1- 4 have been contacted by the Manor Transition Project Specialist. Plans for Resident Engagement was shared at this time.
- The Future Focus Newsletter is being used as an additional method of communication.
- Family Engagement is encouraged and supported and is the reason we are here tonight!



- All families of residents of houses #1- 4 have been contacted by the Manor Transition Project Specialist.
- Feedback gathered from tonight's Roundtable to be gathered to help determine next steps in Family Engagement.
- Families of residents in houses #1- 4 to be made aware when 1:1 conversations will be held with residents in coming weeks.
- Elmwood encourages all families to engage in transition process and to provide input.

Team Member Engagement Update

- Our Team Members are instrumental in ensuring the success of the initiative.
- Resident groupings for the first four (4) homes will be communicated just prior to sharing information with residents.
- Team Members play an integral role in supporting residents through their transition journey.





As with residents, the importance of Team Members to be informed. Team Members to be informed prior to residents to ensure they have the information needed to support residents when questions, and concerns are raised. This will occur through Team Member huddles and email to ensure all are informed.

Importance for Team Members to have information as they, too, will be impacted by transition.

Team Members will play an integral role in supporting residents through their transition journey.

Outcomes and Evaluation Update

- Partnership with the University of Saskatchewan – Community University Institute for Social Research (CUISR)
 - Quality of Life Focus





Elmwood Residences Inc. is partnering with the University of Saskatchewan - Community University Institute for Social Research (CUISR) to evaluate the Manor Transition Initiative and specifically its impact on the quality of life of those we serve.

Dr. Isobel Findlay will serve as lead researcher and the Ministry of Social Services – Community Living Service Delivery (CLSD) as the funder for this important research to support our Disability Service Partners nationally and internationally who are also undertaking this type of initiative.

Timeframes

- Community Homes 1-4 to be completed and ready for occupancy by late 2023 to mid 2024.
- Home Openings will be staggered over several months to ensure residents have the support needed to make their transition.
